Jay's Chronology

1. Approximately 1 hour after call, Adnan at Rich Avenue
2. Security Square Mall shopping
3. Adnan back to school for 1st period after lunch
4. Jay to Jennifer's, [REDACTED] Avenue. Several trips to store and back
5. Jay gets two (maybe 3) calls on cell phone from Adnan, one to see if phone is on and one to say he's leaving school.
6. Waits for "come get me" call but leaves before it comes in. Goes to Jeffs @ [REDACTED] [REDACTED] Road but Jeff not home. Jay then heads for home to [REDACTED] Avenue. Jay at Bardswell and Craigmont when Adnan calls, "Meet me at Best Buys"
7. They leave Best Buys following each other to Rt. 70 Park and Ride where Honda with Hae's body in trunk is left and both leave in Honda. (Adnan moves stuff?? from front of Nissan to trunk)
8. Travel south on Cooks Lane towards Edmondson while unsuccessfully calling [REDACTED] Road, Patrick, for grass connect.
9. Head for NWD to cop grass via Rt. 40, Johnnycake, Ingleside, Forest Park to Norfolk and Granada where connect 2 dime grass. Talked to girl ??? while driving past Forest Park golf course.
10. Then to "cliffs" to smoke dope via Cooks Lane, Old Edmondson, Ingleside, Frederick to Hilltop and dead end at "cliffs".
11. Smoke dope at "cliffs", sun going down.
12. Leave "cliffs" to take Adnan back to school for alibi track practice. Adnan talks to his mother @ being late because of track practice.
13. Jay travels via Beltway to "Christie and Jeffs" @ [REDACTED] near Wilkens Avenue & Maiden Choice Lane, arriving @ 5:20 or 5:30. Smokes some dope and then Adnan calls "Come get me!"
14. Jay back to Woodlawn High via Beltway gets Adnan outside gym, thinks "Will" was with Adnan. Jay thinks about 6 PM.
15. Both now back to Christy and Jeffs via Ingleside, Frederick, Paradise and Maiden Choice. While there Adnan gets 3 incomings, 2 from Hae's family (one maybe a misdial by Hae's family) and then call from Police
16. Adnan then asks Jay to help get rid of body. They drive to Jay's house, get shovels, then to Park and Ride where Adnan gets into Nissan telling Jay to wait at McDonalds on Security. Jay thinks it's @ 20 minutes before Adnan shows.
17. Jay in Honda then follows Adnan in Nissan to Rolling to Dogwood to Holyfield to Johnnycake back to Woodlawn. Maybe around 7PM now. Then to Dogwood to Kernan to Security to Forest Park to Franklinton to burial site.
18. After arguing they leave and park Nissan in front of 4651 Briarcliff and both in Honda back to burial site to dig grave. Snow on ground but melting.
19. While in woods digging 2 incoming, one from Jennifer and one unknown. Leave to go back to Briarcliff for Nissan and body. Jay doesn't go back but waits at Briarcliff.
20. 10-15 minutes later, Adnan back to Briarcliff, "Help me!"
21. Both back to grave, finish covering body.
22. Back to Briarcliff and get Hae's car. Jay in Honda follows Jay in Nissan to 300 S.

Edgewood where Nissan dumped. Jay says it seemed like Adnan knew where he was going.

23. Back to Westview Mall via Edmondson Avenue where Hae's things and shovels dumped at dumpsters behind Mall
24. Jay remembers Adnan taking him home, Jennifer states she meets both of them in front of Westview Mall where she picks up Jay and sees Adnan.
