On Sunday March 29, 2015 at approximately 0349 hours, I (Pfc. C. Obst # 107) was dispatched to return to the Westminster Police Department to meet a complainant regarding a welfare check of his child.

Upon arrival at the WPD, I met with Brian Scott Rice () and was advised of the following information:

Rice was holding a copy of a valid Final Protective Order (#1002SP000752015 - up to 1/2016) outlining the address of () (Westminster, MD 21158). He advised that the respondent in this Final Protective Order is listed as Andrew Peter McAleer (). In the order, it is outlined that Andrew McAleer is not to have any contact with the petitioner or the property.

It was learned the listed petitioner is Karen Lee McAleer.

Rice further stated that he and Karen Lee McAleer used to be married and they currently have a child together. Rice further stated that he is not listed anywhere in the Final Protective Order. Rice informed me that he was "driving by" the address of his ex-wife and observed the vehicle registered to Andrew McAleer on the front yard. He then wanted police to respond to the home and "arrest" Andrew McAleer.

I advised that Police would respond to the address and conduct a welfare check on the mutual child ().

Rice was not satisfied with this plan of action. Rice wanted Andrew McAleer arrested if he was on location.

I asked Rice if Karen McAleer was home, and if she had made any previous calls to police reporting the presence of Andrew McAleer or any Final Protective Order violations. Rice was not aware of any. Further, I asked why he responded to WPD at 0349 hours to attempt to enforce an Protective Order that he was not listed in. Rice replied "Sorry to waste your time" and "Heads will roll if something happens to her or the children, if you do not go arrest him" (referring to Andrew McAleer). Rice further stated that he as a "Lieutenant in the Baltimore Police Department, and if we handled this call, he would be locked up instantly on the active order". Rice continued to be unsatisfied with my answers and plan of action.

I then asked Sgt. Ensor to speak with Rice. Sgt. Ensor is familiar with Rice and agreed to speak with him. Sgt. Ensor attempted to get identifying information for Rice without success. After a few moments, Rice attempted to leave the Westminster Police Department stating that he was "wasting" our time.

Prior to returning the copy of the Final Protective Order to Rice, I advised that I would make a photocopy of the order for the incident report file. Rice attempted to grab the Order from my hand.

I proceeded to copy the Order and returned the original copy to Rice. I advised him that Police would respond to the home to check the welfare of (). I asked Rice for a cell phone number for which he could be reached. He provided me a

cell phone number of [REDACTED]. He then left the WPD without further incident.

WPD Officer's responded to 345 Bradford Drive and made contact with Kimberly Ann Gregory [REDACTED] and Gail Leslie Boblitz [REDACTED]. WPD Officers were advised that Karen Lee McAleer was currently on duty with the Baltimore City Police Department and both Gregory and Boblitz were watching Karen McAleer's children.

Boblitz and Gregory showed all children to be safe sleeping. Further, Andrew McAleer had not been in the home, nor has he been in quite some time. He stays somewhere else, but leaves his vehicle on the property. There were no threatening conditions visible to officers on scene.

While inside the home, Boblitz contacted her daughter, Karen McAleer. She then handed the phone to Sgt. Ensor.

During the conversation, Karen McAleer stated she did not know that Rice had a copy of her Final Protective Order against Andrew McAleer. She is unsure how he had obtained the copy as well.

Sgt. Ensor will follow up with Baltimore City Police Department and Karen McAleer later this date.

WPD Officers then left the home.

I then attempted to contact Rice via the number he provided me. This number went to a loud busy "beeping" sound with no option to leave a voice mail.

I then returned to WPD and used the ICIS Reporting system to see if WPD had another number listed for Rice.

I then learned Rice's number [REDACTED]. The difference was the exchange from a "0" to "8".

Upon calling this number, an unknown female answered. I asked for Brian Rice and she then handed the phone to him. I advised him that I called the number he originally gave me, and I advised the number was not good.

Rice then replied, "How did you get this number then". I advised him that he is in the WPD System, and we had the correct number. Rice did not admit to giving me a fictitious number.

I advised Rice that his child was safe and sleeping. Further, that Andrew McAleer was not in the home.

Rice stated that "he" (meaning Andrew McAleer) must have ran out the back door when officers knocked on the front door.

I advised that we had officer's viewing the rear of the home prior to knocking and no one came out the rear door.

Rice did not seem pleased with the news that Andrew McAleer was not in the home. I advised Rice to allow Karen McAleer to control her Protective Order and to summon police if she feels the Order is in violation. I advised Rice that it was not his responsibility to enforce Karen McAleer's Final Protective Order.

Rice then said "Thank you" and hung up on me.

Case status is listed as CLOSED. Sgt. Ensor will be contacting Baltimore City Police Department Commanders to advise them of this incident.
