ON 4-12-15 KGA ADVISED OF A SUPERVISORS COMPLAINT IN THE 1700 BLK OF FULTON IN REFERENCE TO A MR. RODNEY CLARK 4 [REDACTED] OR 4 [REDACTED] CALLING STATING THAT HE WITNESSED OFFICERS ASSAULTING A UNKNOWN SUBJECT IN THE AREA AND THAT HE HAS A VIDEO IN HIS POSSESSION.

I MADE SEVERAL ATTEMPTS IN CONTACTING MR. RODNEY CLARK BACK IN REFERENCE WITH THE NUMBERS THAT WERE GIVEN BY KGA WITH NEGATIVE RESULTS WITH REGARDS TO SPEAKING WITH MR. RODNEY CLARK.

AN AREA CANVASS IN THE 1700 BLK OF FULTON AS WELL AS GENERAL VICINITY WAS ALSO MADE WITH NO OTHER WITNESSES IN REFERENCE TO THE ALLEGED INCIDENT.

ATTEMPTS TO MR. CLARK WERE MADE AT 1013HRS, 1020HRS AND 1217HRS.

THERE WERE NO UNITS IN THAT AREA EXCEPT 7B09(RICE), 7B31(NERO) AND 7B33 (MILLER) WHO WERE CONDUCTING PROACTIVE ENFORCEMENT IN THE 1600 BLK OF NORTH AVE.

AN ARREST WAS MADE IN THE 1600 BLK OF NORTH AVE. SUSPECT WAS A DONTA ALLEN M/B/7-9-92 WHO LIVES AT 1616 STEPHENS ST. OTHER THAN THAT NO OTHER UNITS HAD CALLED OUT ANYTHING IN THE AREA.

CALLER RODNEY CLARK ALSO CALLED KGA AGAIN IN REFERENCE TO THE SAME INCIDENT AND IT WAS ALL DUPED INTO THIS COMPLAINT.

ON 4/15/2015, DETECTIVE TEEL, LT. NORRIS AND COL. GREEN RESPONDED TO SHOCK TRAUMA TO CONDUCT A CONDITION CHECK ON VICTIM FREDDIE GREY. AT THIS TIME, I SPOKE WITH DR. STEIN WHO ADVISED THAT MR. GRAY IS CURRENTLY ON LIFE SUPPORT AND BEING TREATED FOR CRITICAL INJURIES TO HIS SPINE (C4 AND C5 AREAS). DUE TO THE SPINAL INJURY, HE SUFFERED A STROKE AND BRAIN DAMAGE FROM THE LACK OF OXYGEN. MR. GRAY HAS BEEN UNDERGOING SURGERIES TO STABILIZE HIS SPINAL CORD AND TO CONTROL HIS FREQUENT SEIZURES. DR. STEIN ADVISED THAT THIS TYPE OF INJURY CAN RESULT FROM ANY SWIFT MOVEMENTS OF THE HEAD AND NECK. FORTHCOMING CARE IS NOT DETERMINED AT THIS TIME.

ON 4/15/2015, I CONTACTED WITNESSING OFFICER PORTER TO CONDUCT A FOLLOW UP IN REFERENCE TO THIS INCIDENT. PORTER CONFIRMED THAT HE RESPONDED TO DOLPHIN AND BAKER ST FOR TO ASSIST UNIT 7B91. HE ADVISE THAT WHEN HE ARRIVED, OFFICER GOODSON GOT OUT AND RESPONDED TO THE

REAR OF THE WAGON. OFFICER PORTER ADVISED THAT AS THE DOORS OPEN, HE OBSERVED MR. GREY, LYING ON HIS STOMACH, HEAD FACING THE FRONT OF THE WAGON WITH HIS FEET TOWARDS THE DOORS, SAYING "HELP". OFFICER PORTER ADVISED THAT HE ASKED MR. GREY WHAT HE NEEDED AT WHICH TIME HE STATED THAT HE COULDN'T BREATHE. OFFICER PORTER ASKED MR. GREY IF HE NEEDED A MEDIC IN WHICH MR. GREY STATED "YEAH". OFFICER PORTER THEN ASKED MR. GREY AGAIN IF HE NEEDED A MEDIC AND REQUESTED MR. GREY TO GET UP. MR. GREY STATED "I CAN'T GET UP", SO OFFICER PORTER ADVISED THAT HE ASSISTED MR. GREY OFF THE WAGON FLOOR AND ONTO THE BENCH. OFFICER PORTER STATED THAT HE COULD NOT RECALL IF OFFICER GOODSON REQUESTED A MEDIC BECAUSE HE BEGAN TO HEAD BACK TO 1600 W. NORTH AVE TO ASSIST 7B09 IN A SECOND ARREST. BASED ON THE STATEMENTS MADE BY OFFICER PORTER, I ENDED THE CALL AND ADVISED THAT I WOULD SPEAK WITH HIM LATER ON THE ISSUE.
