HE WAS TRANSPORTED TO THE JAIL.

Arrest of Mark Free

STANLEY SAID I KNOW WHO I WANT AND THAT IS JOEY WATKINS JOEY IS THE ONE THAT HAD THE REASON TO KILL ISAAC.

STANLEY ADVISED HIM OF HIS RIGHTS VERBALLY.

MARK SAID HE UNDERSTOOD THE RIGHTS. MARK THEN READ OVER THE WAIVER AND SIGNED IT.

STANLEY SAID I KNOW YOU HAVE WANTED TO GET THIS OFF OF YOUR CHEST BECAUSE YOU HAVE CONFIDED IN SEVERAL PEOPLE.

STANLEY NAMED THE PERSON THAT HE HAD CONFIDED IN:

TODD BECKSTEIN

HUGH DON WHITE

STANLEY SAID HE NAMED THEM TO SHOW HIM HE WAS NOT TELLING A LIE

STANLEY TOLD MARK THAT THE CULPRIT IS JOEY AND THAT HE SUCKED YOU IN LIKE A SPIDER

STANLEY SAID HE WOULD LIKE FOR MARK TO GIVE HIM HIS VERSION OF WHAT HAPPEN AND FOR HIM TO TAKE IT TO COURT WE TOLD HIM THEY WOULD BE THERE TALKING ABOUT THE INMATES. MARK SAID THEY JUST WANTED THE REWARD.

I TOLD MARK THEY DID NOT WANT THE REWARD THEY WANT TO GET JUSTICE. MARK SAID I WASN'T WITH JOEY AND I AINT GOT NOTHING ELSE TO SAY.
