

where he/she is being incarcerated.

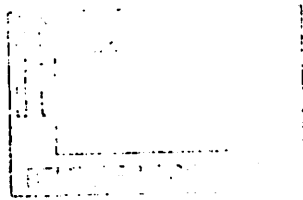

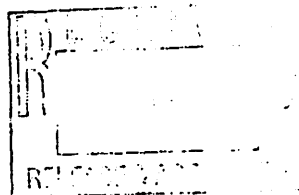


