NARRATIVE:

WHILE ON ROUTINE PATROL, THIS REPORTING OFFICER OBSERVED THE ABOVE LISTED SUBJECT STANDING IN THE PARKING LOT OF THE GOLDEN GALLON HOLDING A LARGE METAL PIPE. THE ACCUSED WAS YELLING AT THREE OTHER SUBJECTS ACROSS THE PARKING LOT. MR. WATKINS WAS ARRESTED WITHOUT INCIDENT. MR. REDDEN WAS STANDING BESIDE THE OPEN PASSENGER DOOR OF MR. WATKINS VEHICLE DURING THIS. MR. WATKINS STATED THAT THE THREE SUBJECTS HAD EARLIER FOLLOWED HIM AND HIS SISTER THREATENING AND HARRASSING THEM.

MR. REDDEN IS RECOVERING FROM INJURIES, HE SAYS HE RECEIVED WHEN TWO OF THE THREE ASSAULTED HIM. MR. WATKINS AND MR. REDDEN STATES THAT THESE THREE HAVE THREATENED TO HARM THEM IF THEY TESTIFY AGAINST THE THREE IN COURT. THE OTHER THREE INDIVIDUALS ARE AS FOLLOWS:
