

1 Statement of: Reggie Hubbard (RH)

2 Ref: Isaac Dawkins

3 Officer: Capt. Tommy Shiflett (TS)

5 TS: Statement of Reggie Hubbard taken County Police Department - approximately  
6 ten minutes after 4:00 - day's date's November the 29th uh, 2000 - statement's reference to the  
7 shooting death of Isaac Dawkins -- your name is Reggie Hubbard.

8 RH: Yeah.

9 TS: And how old are you Reggie?

10 RH: 21.

11 TS: And where do you live?

12 RH: 529 Elliott Drive.

13 TS: And that here in Rome, Georgia.

14 RH: Yes.

15 TS: Okay, uh, you told me that around January you were in Community Service - that  
16 correct?

17 RH: That's correct.

18 TS: And what was you serving that for?

19 RH: Uh, possession of marijuana.

20 TS: And during one of these work days - do you remember what month it may of  
21 been?

22 RH: It may of been January or February.

23 TS: Okay --

24 RH: I'm not certain.

25 TS: but - -one of these work days, your detail was to pick up trash on the highway - is

26 that correct?

27 RH: Well not highways, but County roads.

28 TS: County roads - and ya'll had taken a break and gone to Ryan's to eat - am I

29 correct in assuming that?

30 RH: That's correct.

31 TS: Okay, tell me what happened while you were at Ryan's.

32 RH: I was uh, reading a pamphlet that was posted on the wall about the shooting death

33 of Isaac Haw-- Dawkins and uh, I read it out loud and it said \$10,000.00 cash reward and you

34 know, I made a big it being \$10,000.00 cash reward and some - someone down the line made a

35 comment - that's what you get when you mess with someone's old lady.

36 TS: And do you know who that someone was?

37 RH: I believe it was Joey Watkins.

38 TS: And prior to uh, this interview, you asked if I had a photo of Joey Watkins - is that

39 correct?

40 RH: That's correct.

41 TS: And I produced a photo for you and you said - that's the man that --

42 RH: That's correct.

43 TS: Did you identify that photo as the man that said that?

44 RH: Yes sir.

45 TS: And what was his exact words?

46 RH: 'At's what you get when you mess with someone's old lady.

47 TS: Did you have any more conversation with him that day?

48 RH: Nope.

49 TS: Or any other day?

50 RH: Nope.

51 TS: Uh, but you had heard rumors and have talked about rumors involved in this case -

52 is that right?

53 RH: Yes.

54 TS: Okay, do you remember anybody else that was on that work detail with you what -

55 - who they may of been?

56 RH: Uh, there wouldn't that many people there that day I 'member that uh, maybe a old

57 man - old man uh, I forget his name, last name Reardon -- he was there I know and uh, - 's 'bout

58 all I can think of.

59 TS: Okay, when this man is - that we've identified as Joey Watkins said -- will you

60 repeat what he said again, the exact words.

61 RH: That - that's what happens if you -- if you mess with someone's old lady.

62 TS: Did you make any determination of what he meant by it or do you --

63 RH: No, I just thought it was somebody you know, running their mouth you know,

64 people - that's what we do on that crew you know - half the people in there's been in jail and

65 locked up and, you know, that's just common talk amongst guys.

66 TS: Okay, is anything else you can add to this?

67 RH: Not that --

68 TS: Alright, thanks -- end of statement, approximately twelve minutes after.
